I agree to indemnify, defend and hold harmless the City of Diamond Bar and its agents, officers, servants and employees from any third party liability arising from, caused by or resulting from my participation in the event, including any attorneys fees, expert fees, costs of litigation incurred by the City and the amount of any damages and judgments awarded against the City arising from my negligent or wrongful actions or omissions.
