REQUIREMENTS - DUE BY FRIDAY, MARCH 4, 2016

Space is limited. Priority will be given to Diamond Bar based organizations. Applications will be accepted until deadline or until all spaces are full. Limit 3 rides per organization.

All organizations must provide the following documents:

- Completed application
- Certificate of General Liability Insurance—\$1,000,000 per occurrence
- Additional Insured Endorsement - The additional insured Endorsement must contain the following recital: City of Diamond Bar, its officials, employees and agents as additionally insured.
- 501(c)3—Proof of non-profit status (Issued from IRS)
- Articles of Incorporation with State of California seal

Failure to provide all the required documents to the City of Diamond Bar on above due date may result in cancellation of acceptance to participate in the event .

CITY BIRTHDAY PARTY INFORMATION

Day of Event Procedures: Booth operators may arrive and check in anytime between 9am and 10:30am. Booths must be ready for operation by 11am and stay operation until 6pm. Upon arrival please check in with City Staff to verify ride location.

The space will consist of the following equipment:

- (1) 10x10 canopy
- (1) 6ft table
- (2) chairs.
- All rides will receive a professional operator to physically operate the ride. The organization in in charge of checking wristbands.

Your ride will be assigned to you. An e-mail prior to the event will be sent with your ride Information. Space is limited and Diamond Bar Based organizations will have first priority. A maximum of three booths of any combination (game or ride) can be operated per organization.

RULES AND REGULATIONS

- Submittal of completed application does not constitute acceptance into the event by the City. Priority will be given to Diamond Bar based organizations. To qualify as a local non-profit organization, the organization shall have a minimum membership of 60% Diamond Bar residents. A membership roster will be needed to verify priority prior to the March 4 deadline.
- Ride vendors are not allowed to pass out organizational information at their booth. If you would like to promote your organization then please purchase an information booth.
- Vendors may provide organizational signage to hang at their table - **no tape allowed on canopies**.
- Each vendor is responsible for organization's own equipment and merchandise. The City of Diamond Bar will not be liable for any lost, stolen, or misplaced merchandise or equipment at the event.
- Ride operators will receive a portion of the proceeds from the wristband and game card sales.
- We recommend 2 volunteers to operate your ride at a time. For youth organizations, at least one adult over the age of 21 needs to be present at all times. Please do not leave your area unattended. City staff will monitor every 30 minutes to ensure your constant participation.
- Parking is on your own. Shuttles will operate around the surround neighborhood starting at 10am.
- Additional information will be provided prior to the event with ride assignments and frequently asked questions.
- If you feel that you need additional information, or have further questions. Please feel free to schedule a personal one on one meeting prior to March 4, 2016 (not mandatory).

Failure to comply with any of the above listed rules and regulations may result in immediate forfeit of participation in said event. In addition, it may forfeit your organization's opportunity to participate in future events based on City staff's recommendations.
