### APPLICATION – DUE FRIDAY, OCTOBER 22, 2021

Space is limited. Priority will be given to Diamond Bar based organizations. Applications will be accepted until deadline or until all spaces are full.

**All organizations must provide the following documents:**

- Completed application
- Certificate of General Liability Insurance - \$1,000,000 per occurrence
- Additional Insured Endorsement - The Additional Insured Endorsement must contain the following recital: City of Diamond Bar, its officials, employees and agents as additionally insured.
- 501(c)3 - Proof of non-profit status (Issued from IRS)
- Articles of Incorporation with State of California seal
- **Liability Waiver:** A City of Diamond Bar Liability Waiver (attached) is required to be signed by each vendor and turned in with the application.

**Failure to provide all the required documents to the City of Diamond Bar on above due date may result in cancellation of acceptance to participate in the event.**

### WINTER SNOW FEST INFORMATION

**Day of Event Procedures:** Booth operators may arrive and check in anytime between 7:00am and 7:30am. Booths must be ready for operation by 8am and stay in operation until 2pm. Upon arrival, please check in with City Staff to verify game/activity location at the City canopy.

The space will consist of the following equipment:

- (1) 10' x 10' canopy - shared
- (1) 6ft table per game
- (2) chairs
- All game or activity supplies needed.

Your game or activity will be assigned to you in a confirmation e-mail prior to the event. Space is limited and Diamond Bar Based organizations will have first priority. Organizations are limited to 3 game or activity booths of any combination.

## RULES AND REGULATIONS

- Submittal of completed application does not constitute acceptance into the event by the City. Priority will be given to Diamond Bar based organizations. To qualify as a local non-profit organization, the organization shall have a minimum membership of 60% Diamond Bar residents. A membership roster will be needed to verify priority prior to the December 1 deadline.
- Vendors may provide information about their organization at their designated table space. Please only handout or discuss organizational information if participant inquires. Walking the grounds to sell merchandise or handout fliers is strictly prohibited.
- Vendors may provide organizational signage to hang at table - **no tape allowed on canopies.**
- Each vendor is responsible for organization's own equipment and supplies. The City of Diamond Bar will not be liable for any lost, stolen, or misplaced supplies or equipment at the event.
- Game and activity booth operators will receive a portion of the proceeds from the wristband and game/activity card sales.
- We recommend 2 - 3 volunteers to operate at your game/activity booth. For youth organizations, at least one adult over the age of 21 needs to be present at all times. Please do not leave your area unattended. City staff will monitor every 30 minutes to ensure your constant participation.
- Parking is on your own.
- Additional information will be provided prior to the event with game/ activity assignments and frequently asked questions.
- If you feel that you need additional information, or have further questions, please feel free to schedule a personal one on one meeting prior to November 12, 2021.
- Event may be modified or cancelled per Los Angeles County Health Department guidelines found at <http://publichealth.lacounty.gov/media/Coronavirus>. Vendors are required to comply with all current guidelines at the time of the event.
- **Cancellations** - All cancellations must be received by Monday, November 8, 2021 for a full refund. No exceptions.

Failure to comply with any of the above listed rules and regulations may result in immediate forfeit of participation in said event. In addition, it may forfeit your organization's opportunity to participate in future events based on City staff's recommendations.
